Art Entry Form and Information

To celebrate World Wetlands Day 2010, WetlandCare Australia is hosting its 3rd annual Australia-wide Art and Photography Competition, with categories for Children and Adults. We are seeking artworks exploring the themes of “Wetlands, Biodiversity and Climate Change” which is the theme for World Wetlands Day 2010. The works must be on paper, with a maximum size of A3, and may use pen, paint, ink, pencil, pastel, crayon, charcoal etc.



A limit of two artworks per entrant applies. A separate entry form is to be filled out for each entry.

The competition is acquisitive, and the winning artworks and photographs may be used by WetlandCare Australia and the Major Sponsors for promotional material, including a post-competition poster. The winning photographs may also be part of travelling exhibitions. They may also be used to develop products for fundraising by WetlandCare Australia. The artist will always be acknowledged by name wherever a work is reproduced or shown. See the Rules of the Competition for more details.

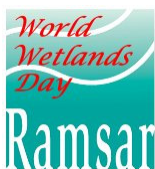

RULES OF THE WETLANDCARE AUSTRALIA NATIONAL ART AND PHOTOGRAPHY COMPETITION 2010

1. Closing date for receipt of entries is: 5.00pm, 4th December 2009. No entries will be accepted after this date unless postmarked 4/12/09.
2. All entries must be posted to: WetlandCare Australia, WWD10 Art, PO Box 114, BALLINA NSW 2478 (Courier address is 53 Tamar St Ballina 2478) and contain a stamped, self-addressed envelope or postage for the return of works that do not win a prize.
3. While WetlandCare Australia will endeavor to return all non-prize winning works, WetlandCare Australia holds no responsibility for the return of artworks.
4. A limit of two artworks/photographs per entrant applies. A separate entry form is to be filled out for each entry.
5. Entry forms must be fully and correctly completed, otherwise entrant may be disqualified.
6. All entries must be the original work of the entrant.
7. Each entry must relate to the theme decided for the competition.
8. The art work or photograph should be on paper either A4 or A3 size with the artist's name, the category entered and title of the work should be clearly printed on the back of the artwork.
9. Artwork and photography must not be framed
10. Entrants in the Art Categories may use ink, pen, pencil, crayon, pastel, paint, charcoal, or similar.
11. Winners of the Photography prizes must provide WetlandCare Australia with a digital copy of the artwork (if the image is digital).
12. Entrants in the Photography prize may use digital, film or slide photography and indicate on entry form if image is digitally enhanced
13. Entries will be judged by a judging panel established by WetlandCare Australia and may include representatives of the Sponsoring organisations.
14. Entries will be judged using the following criteria of (in order): engagement with the theme, artistic expression, quality of presentation, content, and age for Children's entries.
15. The WetlandCare Australia National Art Competition 2010 is acquisitive, with the winning artworks becoming the property of WetlandCare Australia.
16. The entrant, by entering the competition and accepting a category prize or merit award, agrees that the winning entry is acquired by WetlandCare Australia AND that they grant WetlandCare Australia a non-exclusive licence* to use a reproduction of the winning artwork for five years from 1 January 2010. The work may be reproduced, in whole or in part, by WetlandCare Australia for their projects, media and promotions. The artist will be recognised by name wherever the work is reproduced.
17. The winning artworks and photography may be used to develop products for fundraising by WetlandCare Australia, under a non-exclusive licence* for five years from 1 January 2010, if the entrant has signed the relevant section of the entry form. The work may be reproduced, in whole or in part, for the development of products for promotional and fundraising purposes by WetlandCare Australia. The artist will be recognised by name wherever the work is reproduced. WetlandCare Australia is a not-for-profit organisation, with all proceeds from fundraising going to projects such as wetland restoration and conservation.
18. The major sponsoring organisations with naming rights to category prizes may use reproductions of the winning works for promotional and media purposes until 2 October 2010, under agreement with WetlandCare Australia. No artwork will be used for fundraising purposes by sponsoring organisations, and the artist will always be acknowledged by name and prize won wherever their work is reproduced.
19. The entrant, by entering the Open Art category of the competition and accepting a category prize or merit award, agrees that they grant Department of Environment, Water, Heritage and the Arts (DEWHA) a non-exclusive licence* to use a reproduction of the winning artwork for five years from 2 February 2010 under agreement with WetlandCare Australia. The work may be reproduced, in whole or in part, by DEWHA for their media and promotions. No artwork will be used for fundraising purposes by DEWHA, and the artist will be recognised by name wherever the work is reproduced.
20. Selected entries may be displayed at one or more art exhibitions, or at other venues, including an online exhibition on the WetlandCare Australia website.
21. The competition is not open to staff of WetlandCare Australia or their immediate families.
22. Winners will be notified on or before 18th December 2009. Winners names will be also be published on the WetlandCare Australia website.

**A non-exclusive licence means that the artist agrees that WetlandCare Australia can use a reproduced image of their artwork in the manner and for the purposes specified in the Rules of the Competition, for the specified and agreed time period. The artist continues to hold copyright of the artworks during and after the specified time period.*
